The above member hereby agrees to the following as a condition of membership:

• **Annual Membership**

- 1. Annual club membership is limited to 17 Unlimited and Limited Members. Existing members will have preferential renewal right when maximum level is reached.
- 2. Annual membership is effective March 15, 2014, and expires November 15, 2014, irrespective of the actual date member joins or limitations due to water shortage.

• **Annual Dues:** Full payment is due by March 15, 2014.

[†]Family Packages can only be purchased by Unlimited or Limited Members. Only family members under the age of 17 or who ski fewer than 25 sets per year qualify to use sets from a Family Package.

• **Skier Qualification**

- 1. All members must maintain active membership in USA Water Ski and must provide a photocopy of current membership card.
- 2. All members must complete and sign the Release and Reimbursement Form.

• **Privileges**

1. Membership privileges include use of club ski boat, boat dock, and slalom course.
2. Time allowed for Slalom: 6 entry gates or equivalent each set; 20 minutes dock to dock
3. Time allowed for all other water activities (i.e. Tricks, Barefoot, Wakeboard, Kneeboard, etc.): 20 minutes dock to dock.

- **Boat Usage and Equipment**

1. Members must log their sets and gas usage in the provided log books daily.
2. The engine oil should be checked before each use. Additional oil must be added if needed. All gauges should be within normal operating range. Members are responsible for regular oil changes as recommended by the manufacturer—every 50 hours for engine oil and every 100 hours for transmission fluid.
3. The member is responsible for any damage to the boat or other equipment. This includes damage to the hull, interior, engine, propeller or buoy course.
4. Should any damage occur, it is the responsibility of the member to notify Triple J Ski Ranch, Ltd., in a timely manner.
5. The bow of the boat is to stay covered and off-limits to everyone.
6. Qualified guests can drive the club boat, though the host member is responsible for the actions of any guest. All guest drivers must be active members of USA Water Ski and be covered by USA Water Ski insurance.
7. When finished using the boat, it must be wiped down and stored in its slip securely. Gas tank should be refilled to above the quarter full level.
8. Each member is responsible for bringing their own ski equipment including ropes, handles, skis, vests, and gloves.
9. Anyone who dislodges a boat guide, ski buoy or magnet is responsible for its immediate replacement. Spare buoys should be available at the dock. Cost of replacement is the Member's responsibility.

- **Rules Pertaining to Guests:**

1. Guest fees: \$30.00/set.
2. Each guest is limited to 6 sets per season.
3. Each member is limited to 24 guest sets per season.
4. Guest must be accompanied by a member and must ski with the member.
5. Guest must register and sign Release and Reimbursement Form prior to skiing.
6. Guest must be member of USA Water Ski and sign in with membership number.
7. Member skiers have priority water time over guest skiers.
8. Members are responsible for their guest actions and behavior, as well as any outstanding payment due for Guest Fees or damages incurred.

- **Code of Conduct:** Each member and member guest is expected to practice good judgment and behavior during their visits. Members are to treat property of Triple J Ski Ranch, Ltd., as if it were their own. Common courtesy should always prevail.

This contract (with the Release and Reimbursement Form) comprises the entire agreement pertaining to club membership and no other agreement of any kind shall be recognized or binding.
